

**LOFTUS PARK RETAIL CENTRE: Sports Central Restaurant Voucher Draw
TERMS AND CONDITIONS ("PROMOTION")**

This Promotion, conducted and organised by Loftus Park Retail Centre, is subject to these Terms and Conditions ("T's and C's"), as may be amended from time to time. Please read the T's and C's carefully and pay special attention to all the terms printed in bold.

1. PROMOTER

- 1.1 This Promotion is promoted by Redefine Properties Limited (Registration Number: 1999/018591/06) ("**Landlord**").
- 1.2 **The Landlord will make a final and binding decision in respect of all matters relating to the results, qualifiers and disputes relating to the Promotion and no correspondence will be entered into.**
- 1.3 If considered necessary, the Landlord reserves the right to amend the T's and C's by providing reasonable prior notice.

2. RULES

- 2.1 To enter the Promotion a participant ("**Participant**") must be in possession of a valid South African identity document. If the Participant is younger than 18 years old, the Participant must be able to show consent by a guardian or parent and be accompanied by such guardian or parent, if the Participant receives a prize.
- 2.2 The Promotion may not be entered into by any director, member, partner, employee, agent, consultant, and tenant of the Landlord, the marketing service providers and/or any person who directly or indirectly controls or is controlled by these entities, including their spouses, life partners, business partners or immediate family members.
- 2.3 The Promotion will run on a monthly basis until further notice ("**Promotion Period**"). Any entries received after the Promotion Period will not be taken into consideration.
- 2.4 To enter the Promotion, a Participant will be required to, for the duration of the Promotion Period to-
 - a. Like the Loftus Park Facebook Page.
 - b. Winner will be selected monthly at random.
- 2.8 **Upon compliance with 2.4 a Participant will automatically be deemed to have entered the Promotion.**
- 2.9 A Participant may enter as many times as he/she wishes, but can only win once.

3 PRIZES

- 3.1 The monthly giveaway consists of Loftus Park Restaurant vouchers to the value of R300.
- 3.2 The Landlord will use reasonable efforts to contact the prize winner during working hours (8am until 5pm) via the Facebook account entrant used to "like" the Loftus Park Facebook Page during the Promotion Period;
- 3.3 If the Landlord is unable to reach the monthly prize winner after drawing his/her draw for whatsoever reason, such a prize winner will be disqualified and the draw of a replacement entry shall take place.
- 3.4 Such a replacement winner shall be contacted by the Landlord via the Facebook account entrant used to "like" the Loftus Park Facebook Page during the Promotion Period as soon as reasonably practicable and shall be required to respond to the Landlord set out in such correspondence.

- 3.6 In accepting the monthly prize, the prize winner undertakes to provide the Landlord with any reasonable information to enable it to adhere to the provisions of *inter alia* the Consumer Protection Act, No 68 of 2008.
- 3.7 **The Prize is not transferable and may not be deferred, changed or exchanged for cash and/or any other products.**

- 4.2 **The Landlord reserves the right to terminate the Promotion with immediate effect at any time prior to the end of the Promotion Period, if deemed necessary in its sole discretion or if circumstances arise outside of its control. No Participant will have any claim against the Landlord for such a termination.**
- 4.3 **Participation in the Promotion constitutes automatic acceptance of the T's and C's contained herein and the Participant agrees to abide by the T's and C's.**
- 4.4 All winners in respect of the Promotion may be requested to be photographed so that their photographs may be used for future promotional and/or post promotion purposes in relation to Loftus Park. Promoting platforms will include the Facebook page of Loftus Park as well as community newspapers. No fees will be payable in this regard. **The winners will be given the opportunity to decline the publication of their images.**
